Title of rule and other identifying information: (Describe Subject) chapter 208-690 WAC, implementing the Uniform Money Services Act (chapter 19.230 RCW) must be amended to implement Section 6 of chapter 73, Laws of 2010. Section 6 amends the annual assessment formula. If the rules are not amended by July 1, 2010, the existing annual assessment formula in the rules will be inconsistent with the law as amended by chapter 73.
