1. 208-690-010. The definition of “subdelegate” is amended to clarify.
2. 208-690-035(6). This section is new and is added to provide further guidance to licensees.
3. 208-690-035(7). This section is amended to provide further guidance to licensees.
4. 208-690-040(2). This section is amended to lower the reporting frequency and to clarify “year” to “twelve months.”
5. 208-690-040(3). This section reflects the final determination of the initial bonding amount.
6. 208-690-060(1). This section is amended to state the maximum tangible net worth amount.
7. 208-690-075. This section is amended to clarify the requirement.
8. 208-690-110(2). This section is amended to clarify the requirement.
9. 208-690-130(1) and (2). This section is amended to clarify the required fees.
10. 208-690-130(3). This section is amended to clarify the required fees when licenses are withdrawn or denied.
11. 208-690-200. This section is amended to clarify the receipt requirement.
