

- a. Four Escrow Agents were cited for failing to maintain required reconciliation reports.
- b. Three Escrow Agents were cited for failing to maintain reconciliation reports that list the escrow transaction numbers.
- c. Three Escrow Agents were cited for failing to obtain the endorsement-side of imaged trust account checks.

#### **Simplex Escrow, Inc. and Anh Hoang 2/25/2016** [C-15-1692-16-CO01]

The Department received evidence of unlicensed activity between June 2013 and November 2014 by Respondents Simplex Escrow and Anh Hoang for performing escrow functions in at least 68 Washington State mortgage loan transactions and not satisfying an exception to the licensing requirement under the Act. The Department entered a Consent Order agreeing to these terms:

 Respondent Simplex will not engage in the business of an escrow agent in Washington State before obtaining a license or qualifying for an exemption

• Fine: \$14,000

• Investigation Fee: \$1,000

#### **Title365 Co. 1/28/2016** [C-15-1749-15-CO01]

Between at least February and March 2011, Respondent Title365 Co. performed escrow functions in at least two residential mortgage loan transactions for property located in Washington State. In at least 12 residential mortgage loan transactions for property located in Washington State, Respondent Title365 Co. collected duplicate fees related to settlement and escrow activity in spite of the fact that the borrowers had already been charged settlement and escrow services fees by another entity. In or around November 2015, Respondent Title365 Co. refunded the full amount of the duplicate fees. The Department entered a Consent Order agreeing to these terms:

 Respondent Title365 Co. will not engage in the business of an escrow agent in Washington State before obtaining a license or qualifying for an exemption

Prohibition from industry for 5 years

Restitution: Paid

• Financial Literacy and Education: \$11,000

• Investigation Fee: \$1,000

#### Pinnacle Northwest Escrow, LLC and Michele J. Roberts 2/29/2016 [C-15-1778-16-CO01]

The Department issued a Statement of Charges alleging Respondent Pinnacle Northwest Escrow and Michele J. Roberts failed to comply with the Director's authority in preparation for an examination and was late in filing quarterly reports. The Department entered a Consent Order agreeing to these terms:

• Fine: \$1,750

• 3 year Revocation stayed for 18 months

• Investigation Fee: \$250
