INTRODUCTION

On May 15, 2015, the Securities Administrator of the state of Washington issued a Summary Order to Suspend Registration and Notice of Intent to Revoke Registration, Impose a Fine, and Charge Costs order number S-15-1684-15-TO01 ("Summary Order.") The Summary Order together with a Notice of Opportunity to Defend and Opportunity for Hearing and an Application for Adjudicative Hearing was served on Respondent. Respondent withdrew her investment adviser registration and the Securities Division believes that entry of a Consent Order is in the public interest and is appropriate for the protection of investors. Based on the Findings of Fact and Conclusions of Law set forth in the Summary Order, which are incorporated herein by reference, Respondent and Securities Division agree to the following:

CONSENT ORDER

This Consent Order relates only to Judith French Tronsrue's registration as an investment adviser and is not intended to affect her registration as an investment adviser representative for another investment adviser or as a broker-dealer representative.

IT IS AGREED and ORDERED that Respondent Judith French Tronsrue will not apply for registration as an investment adviser for ten (10) years from the date of entry of this Consent Order.

IT IS FURTHER AGREED that Respondent shall pay a fine of \$1,000 and costs of \$200.
